Risk Management Premium Credit Details

Both insureds and non-insureds can take advantage of educational opportunities provided by MedPro Group. Insureds who successfully complete risk courses may be eligible for a risk management premium credit at their next policy renewal.

HOW TO QUALIFY FOR A RISK MANAGEMENT PREMIUM CREDIT

2-3 CME CREDITS

MAY QUALIFY FOR A 5% PREMIUM CREDIT

1 YEAR PREMIUM CREDIT

2 YEAR PREMIUM CREDIT

3 YEAR PREMIUM CREDIT

- Course(s) should be successfully completed prior to the policy renewal date for which the premium credit should be applied.
- Activities completed prior to 1/1/2026 qualify for maximum 1-Year premium credit.
- Opioid/Pain Management education modules are required for Oklahoma licensure for MDs, DOs, PAs and APRNs. Therefore, no RM credit will be applied for these modules.
- Insureds who have less than 18 months remaining on a 3-Year premium credit may take courses for CME credit to extend the premium credit period.
- Insureds who have more than 18 months remaining on a 3-Year premium credit may take courses for CME credit only. No extension of the premium credit period will be made.
- Completion of a risk management course does not imply or guarantee renewal. Premium credit from PLICO does not imply acceptance of CME credit by a state board.
